Celebration of Gurupurnima

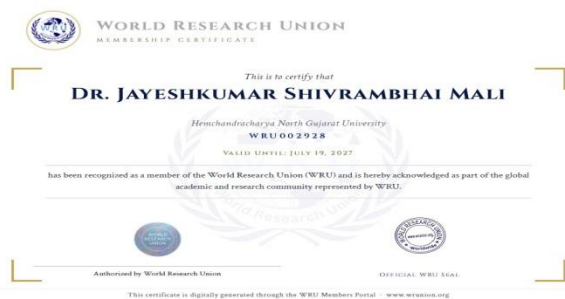
